Plot Overview

Plot Details:

- •Rectangular plot admeasuring ~1,775 sq yards, with right of way of 26 ft in width and
- 151 ft in length
- •There is an electrical sub-station of BEST authority, in rear corner of plot
- Ideal for Commercial use
- Plot has reservation for Theatre
- Property owned by IDBI Bank
- •The original XYZ Theatre structure has been demolished, leaving a vacant plot.

Asset & Business Overview

- •Osian's Connoisseurs of Art Pvt. Ltd. acquired the iconic Minerva Theatre in Mumbai from the Mehra family for approximately Rs. 40 crore.
- •The plan was to redevelop it into "Osianama," an art and cinema museum.
- •To finance the project, Osian's secured loans from IDBI Bank, against the Minerva property and other assets.
- •Osian's defaulted on the loan, and by 2010, the account turned NPA and IDBI Bank took possession of the property under the SARFAESI Act.
- •Osian sold the property to IDBI Bank against part loan settlement, and IDBI Bank took ownership.
- •The bank attempted multiple auctions but received no bids, mainly due to redevelopment restrictions (a theatre must be retained on site).

Location and Connectivity



•Prime Connectivity: Located at 186, Dr. Dadasaheb Bhadkamkar Marg, (known as Lamington Road), Grant Road, Mumbai-400007 (Maharashtra), offering excellent access to major transit points.

•Proximity to Key Stations:

- **Grant Road Station (WR):** Less than **0.1 km** (just across the road)
- Mumbai Central Station (WR & Central connectivity): Approx. 1.2 km
- Key Arterial Roads: Immediate access to Lamington Road, with close proximity to Pedder Road (~2.5 km) and Marine Drive (~1.8 km)
- •Airport Accessibility: Approx. 18–20 km from Mumbai International Airport (Chhatrapati Shivaji Maharaj International Airport)

 Area: Prime South Mumbai locality with high footfall and commercial value
